## GENERAL TERMS AND CONDITIONS

### 1 Instructions to Bidders

#### Submission of bid

The bids are to be submitted in sealed envelope super-scribed with the above bid document name and number , not later than 3:00 PM on 25<sup>th</sup> January 2021

TNRDC reserves the rights to announce L1 bidder only after scrutiny of the Bids submitted and should satisfy the Eligibility criteria for Technical Requirements .

The tender shall be addressed to the Officer inviting tender as indicated in the notice inviting tender. **The Bids should be submitted to TNRDC Office in the above mentioned address not later than 03.00 PM on 25<sup>th</sup> January 2021 and the Bids will be opened on the same date at 03.30 PM.**

- The tenders received after the time prescribed for submission are liable to be rejected. Telephonic/email/fax offers shall not be entertained.
- Any Submission of Bid by FAX or email will not be accepted and shall be invalid.
- Bids which are late/vague/conditional/incomplete/not confirming to the laid down procedure in any respect will be rejected.
- Any submission of document/Bid/letter shall not be entertained after prescribed time of Bid submission.
- Bidder must fill up all the schedules and furnish all the required information as per the instructions given in various sections of the tender specification.
- Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by bidders who resort to canvassing are liable to be rejected.
- Any bid not accompanied by the bid document duly signed in all pages and the **specified cost of bid document** in acceptable form shall be rejected by the Employer as a **Non-Responsive** bid. The bidder shall bear all costs associated with the preparation and submission of their bid and the TNRDC will in no case be responsible and liable for such costs, regardless of the conduct or outcome of the tendering process
- Each page of tender document shall be signed by the authorized person of insurance company. The proof of authorization by competent authority of the insurance company in original shall be submitted with the Bid, without which the Bid shall be liable to be rejected.
- One authorized representative of the bidder can be present while opening the tender.
- The Successful bidder shall at its own cost comply with the provisions of orders and notifications issued by IRDAI and Government from time to time
- The bidder should be a registered insurer of IRDAI and proof towards the same shall be submitted along with the Bid.

The Company/ Agency should also furnish the copies of following documents in addition to the documents mentioned in the tender document:

1. IRDAI Accreditation Certificate
2. List of Government/Semi-Government/ Govt. of India Undertaking/Autonomous Body or Private Body for which such Insurance Scheme has been provided along with the proof
3. A dummy copy of Insurance policy with detailed terms and conditions.

## **2 Bid Validity**

Bid shall remain valid for a period of **90 (Ninety) days** from the date of opening of the bid. The bidder shall not be entitled to modify, vary, revoke or cancel his bid during the said period. The validity of the bid may be extended with the consent of the bidder as and when required for the period as requested by TNRDC in writing.

- Correction fluid is not allowed to be used. In case there is any correction, the Bidder shall score out the same neatly and put his signature and stamp with date near the place of each correction.
- Each page of the bid shall be signed by authorized person. Bidder should ensure that the quoted prices are strictly as per terms and conditions of TNRDC and as per guidelines of IRDAI.
- The Bidder shall quote their annual premium amount for each item in the Price Bid. Also, the bidder shall quote the GST and the total amount of annual premium. The details of assets covered under Section-I of the Priced Bid and the sum insured is provided in the Annexure – I&II.

## **3 Rejection of the Tender**

- TNRDC reserve to itself full rights to reject any or all the tenders without assigning any reasons whatsoever.
- TNRDC reserves the right to accept or reject any tender in part or full without assigning any reason whatsoever.

**Submission of false or incorrect information, history of delayed settlement of claims, reports of unprofessional conduct, among other things, shall be sufficient grounds for disqualification of the bid.**

## **4 Bidder's Responsibility**

- Although all details presented in this bid document have been compiled with all reasonable care, it is the bidder's responsibility to ensure that the information provided is adequate and clearly understood.
- It is the responsibility of the bidder on the quote offered by them and relief or consideration cannot be given for error/omissions.

## **5 Bid Clarification/Amendments by TNRDC**

Any clarifications with regard to the bid document may be obtained from the officer inviting tender of TNRDC

- TNRDC may issue clarifications/amendments in the form of addendum/corrigendum during the bidding period. Bidders shall take such addendum and corrigendum into consideration while submitting their bids.
- Any value additions suggested by the Insurer should be provided in a separate section and financial implications thereof should be shown separately. TNRDC reserves the right to implement such suggestions. However, for the purpose of financial evaluation, the same will not be taken into consideration.

## **6 Confidentiality of Documents**

- Bidders shall treat the bid documents and contents therein as strictly confidential.

## **7 Currencies of Bid and Payment**

- Currencies for bid and payment shall be in Indian Rupees only.

## **8 Evaluation of Bids**

- TNRDC has right to reject any bid without assigning any reason.
- Evaluation would be done on the basis of the information/data provided by the bidders.

## **9 General**

TNRDC reserves the rights to call L1 bidder for negotiations to reduce the price. If that bidder shall not agreeable then TNRDC reserves the right to call another bidder for negotiations.

In case of award of work to the insurance companies, they are required to issue the cover note immediately after receipt of payment of premium by cheque and the policy is required to be issued within 15 days from the date of award of work.

TNRDC has all the rights to change/alter/modify/amend/add/delete the coverage/policy terms & conditions/ Variation of sum insured etc. at the time of placement of insurance policies.

It may also be mentioned that these Bids are directly invited by TNRDC from Insurance Companies hence no commission/ brokerage/ other fees shall be paid to insurance broker/ advisor/ intermediary by the insurance companies and discount in lieu of commission/ brokerage may be passed on to TNRDC.

## **10 Law governing the Contract & Court Jurisdiction**

The Contract shall be governed by the Law for the time being in force in the Republic of India. The Civil Court at Chennai having ordinary Original Civil Jurisdiction shall alone have exclusive jurisdiction in regard to all claims in respect of this Contract.
